





6. Treasurer's Report - Neal Matsunaga

Neal displayed the Treasurer's Report contained in the Annual Report He highlighted the following information:

2020

- Shortfall in income in 2020 almost exactly matches prediction \$45,000. At the time, the 2020 budget was passed, the vestry expected that approximately \$11,500 additional would be pledged. That did not happen. Several pledges have not been paid in full.
- Expenses in 2020 were less than budgeted mostly due to the campus being closed for 9
 ½ months
- Good news The church and the preschool applied for and received a \$111,000 PPP loan (\$73,000 for the church and \$38,000 for the preschool). The treasurer is in the process of submitting paperwork for that to be forgiven.
- \$45,700 of the PPP money will be used to help cover the income shortfall in 2020.
- There are fewer 2021 pledges than 2020.

2021

- The 2021 budget is based on 159 pledges 3 fewer than the 162 pledges in 2020
- Budgeted income for 2021 is \$6000 higher than our actual 2020 income due to increased pledge income and Operating Support income offset by an anticipated decrease in Plate offering income since we do not expect to have on-site service until after Easter.
- Budgeted expenses are \$12,000+ more than actual 2020 expenses due to staff pay increases, the increase in the diocesan assessment and anticipated increase in Administration expenses due to reopening the campus for worship and other activities.
- The anticipated deficit in income for 2021 over expenses is \$52,000. Part of that will be covered by the funds from the PPP loan which were not used in 2020 and the current Pledge Reserve. That will leave an uncovered shortfall of \$520

Concerns for The Future

- Income shortfalls are increasing
- Expenditures for campus maintenance and improvements were funded by the rent on the
 rectory and income from the preschool and cost sharing payment from the groups who
 meet on campus. In 2016, that was changed to allocate those funds to the operating
 budget.
- There is approximately \$86,000 in the campus and rectory maintenance and improvement account.
- A source of funding for campus maintenance and improvement needs to be identified. Our buildings are aging, and the grounds require on-going expenditures.

Questions:

• Steve Bried – Will we apply for more PPP funds in 2021?

Neal: We don't qualify due to requirement for being able to prove at least a 25% reduction in gross receipts between comparable quarters in 2019 and 2020

Pastor Todd took a vote to approve the budget – which is not required by the parish by-laws. The vestry budget was approved



What Is A Deanery?

We are all members of the Diocese of California. We live out that membership in our local congregations as well as a variety of other ministries and institutions, one of which is Deanery. Deaneries play a key role in developing and implementing the policies and plans of the Diocesan Convention and the Executive Council through:

- Reviewing and giving input about the diocesan budget and convention resolutions
- Sharing diocesan information with the congregations
- Communicating with the Diocese about the concerns of congregation sand the deanery
- Providing a forum for education about matters of importance to the Diocese and the congregations
- Nurturing relationships between congregations, organizations and individuals doing similar ministries and good works
- Developing deanery-wide programs and participating in creative ministries

Who can be a Deanery Representative?

Deaneries are made up of lay and clergy representatives from each congregation in the deanery. The number of lay representatives each congregation has is determined by the number of communicants in good standing in the congregation.

Lay representatives are elected by congregations or appointed by the clergy of a congregation. All deanery representatives attend deanery meetings. Some deanery representatives are designated by their congregations as "convention delegates" These people are voting representatives at convention.

What is expected of a Deanery Representative?

- To attend deanery meetings, actively participate in deanery programs and support one another in the deanery
- To report to the deanery meeting about congregational matters and to the congregations about deanery matters
- To read, study and be prepared to discuss matters that come before convention
- If a convention delegate, to attend convention and vote
- To seek out and encourage people to serve on deanery ministries, Diocesan departments and commissions, and Executive Council
- To communicate lay initiatives and concerns to the clergy

When and where do Deaneries meet?

Deaneries are required to meet at least four times a year to elect officers, review the diocesan budget and review resolutions and other matters to be presented at diocesan convention. The times and places of deanery meetings are determined by each deanery. Agendas and programs

for deanery meetings are planned by the officers of the deanery

Deanery Report

The Diocese is composed of six Deaneries which roughly follow county boundaries. St. Timothy's is one of ten churches who are members of the Contra Costa Deanery. Each year our church elects Delegates and Alternates to attend the quarterly meetings and the annual Diocesan Convention.

In 2022 the convention will be held October 21 and 22. Deanery meetings are scheduled for: March 17th, June 16th, September15th, and November 17th. Due to the pandemic meetings are held by Zoom.

One of the responsibilities of Delegates and Alternates is to report back to their respective communities what the church is thinking and actually doing: worldwide, nationwide, in the Diocese and in the Deaneries. Delegates are encouraged to be part of one of the many Departments of Ministry in the Diocese.

Each Deanery receives a small grant from the Diocesan budget. These monies are used by the Deanery to help ministries presently going on throughout the Deanery and to provide "seed money" for new ministries. During our November 2021 meeting two grants were approved:

- Grant to Jewish Family Services (support for Afghans)
- Grant to St Ann's for school uniforms.

Other grants were given throughout the year leaving an ending balance of \$1,614.36 to begin 2022.

Rector's Report

Annual Meeting Feb 6, 2022

Thank you all for your prayers and support. Over the last two years, we have yoyoed from gratitude to isolation and back. We miraculously stayed connected through the deepest freeze of the pandemic and stayed the course through the surges of the delta and omicron variant.

The constant throughout 2021 has been your faithfulness and commitment to our community. We have given time, talent, and treasure to sustain St. Timothy's. We have gone the extra mile to connect, serve, and worship through difficult times. I am ready for us to practice hope in 2022. We can press forward building on pandemic lessons.

Personal goals that came out of sabbatical for me are kindness, curiosity, and flexibility. Because of this space I am more than ready to practice these goals in everything I do and can't wait to see what God has in store next.

Our community is supported by a three-legged stool.

Worship, Service, and Fellowship.

Worship

Livestream

After *much* trial and error, we have a livestream system that works without significant glitches. Did you know it took three paid consultants and countless volunteer hours to find this sweet spot? By late October 2021, I hope you noticed the quality of the video improve dramatically. We are never quite done tweaking, but I am confident 2022 will continue to have a high-quality livestream.

We need you — we need you who care about liturgy and naturally pay close attention to details. You can help us run the system in the back of the church. But "I am not a technology person" you say. If you don't hate technology and can pay close attention with an artist's eye, we need you.

In the Fall of 2021, we projected most of the worship on church screens. I am proud of this expression of liturgy. The intent is to take the best of what is available and make authentic liturgical worship. I took a key role in both designing and executing these digital liturgies with several volunteers who helped build the slides. We will never have "perfect worship," but I am happy that what we have is accessible for newcomers and long-term members. More pointedly, I am happy that low-vision people can worship easily. Side note - we will continue to print the music we use in worship.

Music Director

I am delighted that Myles Ellis joined out team in November 2021. With much gratitude, I look forward to serving with him far into the future. He brings a wealth of talent and energy.

Service

Outreach

In 2021, outreach was the second most visible leg of our community's stool. Food Drives FOTH were clear signs of our commitment to care for our neighbors.

Thank you for supporting all our sponsored ministries. Your contributions to FOTH have been distributed to our ministries. Check the website out under FOTH to see where that money goes. Thank you for donating to our campus food drives in the deepest part of the pandemic and thank you for continuing your work through the last half of 2021 to today.

Fellowship

Pastoral Care

The third leg of the stool that is easily overlooked is fellowship, especially in pastoral care. The vestry and many of you took significant steps to stay connected through the isolating time of 2021. It may feel like the war is over, but loneliness, shock and isolation are still part of our everyday landscape. Young and old alike have needed the connections we give to each other. Are you thinking about someone at St. Timothy's in particular? Call, email, or text them to see how they are doing.

More systematically, your vestry, pastoral care ministries and your clergy continue to engage in with all individuals in our community.

Youth and Family Ministry

I have a difficult item to share with you. I do not hear a deep desire for parishioners and families with youth at home to give volunteer time or create the momentum that is necessary for a designated youth ministry leader to thrive (at this time). Robbie has moved out of the area to share a new life with his partner, Becca. He was an amazing leader, with great organizational skills, and a deep faith. He was sort of a test case for us in 2021, and we won't be seeking a replacement in 2022.

However, through the Fall of 2021, we did discern a deeper desire for pre-K and elementary formation. We have asked Abby, who has been our nursery worker, to expand her role to roughly 5 hours per week. She engages families individually, guides Sunday morning activities, and coordinates once a month movie night.

Small Groups and Food Fellowship

Small groups have been back in business for a while. In late 2021, we went mask less and without any restrictions except that we verify vaccination status, then omicron pushed us backward. We are still discerning how to support food fellowship. L

Associate Rector's Report

Fifty years from now, I do not know what this time will be named. Living in it, we name it now by the variants, the offering of vaccines, and reflect on how our church lives have been disrupted and changed.

The laughter coming from the parking lot in front of Grace House radiated in waves of Spirit that touched my soul. The first people who had been fully vaccinated gathered outside and greeted each other with a welcome that stirred the soul and pierced some of the heartache of isolation. We were filled with hope as more and more people were vaccinated and we could imagine coming back into church to worship again.

God has continued to move in this place, and it is important to remember that Saint Timothy's reached out with prayer on-line, worship on-line, people videoing their songs of praise and prayer and Pastor Todd and our tech team leading us into this hybrid community of on-line worship and inperson worship. We shared food and funds with Monument Crisis Center and offered care for members and friends—through facetime, Zoom and calls.

A year ago, in the season of Epiphany of 2021, worship and most fellowship was on-line. Noah's Ark Pre-school continued in small cohorts, and we continued with chapel outside, noting the trees, hearing the birds, listening to Bible stories, and singing songs. Hearing their happy voices in the playground has been one of my delights! Bible study and Life-story continued on-line. Christian education for our elementary aged children pivoted as we learned Bible stories with games of Kahoot over Zoom. It was fun! Chalk drawings graced our sidewalks, and we grew plants during Lent. Soon, we believed, vaccines were coming for children too. And we celebrate that the vaccines are here for our teens and children!

In the spring we began services outside in the courtyard; we met outside on the picnic tables and although my pastoral care still meant visiting windows outside hospital and facilities, phone calls and facetimes, driveway visits and back yard greetings began to be a possibility. We stretched into remembering worship and church the way it used to be...

Church, however, has changed. We have changed. I believe that we will continue to connect with each other in person and over Zoom and YouTube; community, prayerfully entered into, can be built even over Zoom and with all kinds of communication technologies, even over long distances. In God's mysterious ways, the Spirit moves. This change is demanding and we at Saint Timothy's are prayerfully and enthusiastically responding.

As we gathered, vaccinated and hopeful, grateful for the on-line worshipping community we reremembered the power of in-person worship. We gave thanks for the sun, the flowers, and our stone altar. Our creative altar guild and creative liturgical artists we gathered to celebrate the Eucharist together

Inside the parish Hall two weeks later we cheered with Pentecost and the gift of the Spirit; after a few weeks we made the move back into the sanctuary with a smaller congregation who signed up to be in church in person and continued our chat line during live worship. I have continued to preach and to teach, although on-line feels different!

This past year was filled with pastoral calls, often on the phone. Later, we had small funerals of people who had not been able to gather together for a worship service. We celebrated being able to get together and gave thanks, mourning the loss of a loved one, and also mourning our isolation.

In November, Pastor Todd began his Sabbatical and we worked together as a parish as more people felt comfortable being in church in-person with our masks; we celebrated getting together outside for fellowship. Myles Ellis Joined us as our new Music Director. Some of our children proudly shared at milestones that they were vaccinated! We delighted in the children at young people's time as they sat at a distance with their masks. We celebrated a baptism and gave thanks to be together.

As December and Advent began, children received their countdown to Christmas candles, and we shared pictures of our nativity scenes from home in our Announcements. In an amazing moment, Ade A. became Saint Nicholas, and we were blessed with Saint Nicholas cookies that a whole team made here at Saint Timothy's, despite challenges with the oven! We even had a special light-up Lego nativity and Jesus; Karen A. shared her surprise for young people's time—the Light of Christ for us all to see. We planned a wonderful event for children, a craft time with cocoa and cookies and then a terrific Christmas movie "The Star" in the church with great attendance. Rayne D. helped us make amazing ornaments we took home, and the wonderful narrative of the movie offered a welcome perspective for the Christmas story. Christmas plans were for an early service for children, and two evening services with a candlelit Silent Night.

Then the Omicron variant threw us for a loop. The highly contagious variant meant fewer people in person at church, asking some of our groups that started to meet in person to go back to zoom. Our early service on Christmas Eve meant no pageant, but young readers. Our younger children who were present excitedly held a candle for Silent Night anticipating Christmas. We celebrated Christmas Eve at the 5:00 service with music and candlelight, reveling in the amazing display of decorations and flowers. We live-streamed our 7:30 service with music, choir and candlelight. Some of the activities and highlights in 2021, included:

- 1. Applied for and received forgiveness of St. Timothy's \$111,460 Cares Act Payroll Protection Program for the church and preschool from Heritage Bank and the Small Business Administration.
- 2. Completed audits of the church's (2019 & 2020) and preschool's (2018-2019 & 2019-2020) books. No significant areas of concern were identified nor were any significant suggestions for changes to our procedures made.
- 3. Provided daily cash management and reconciliation of the church and preschool checking and money market accounts. This entails being knowledgeable about anticipated expenses and account balances in the church's and Noah's Ark's accounts.
- 4. Assisted with the search and HR functions for the loss of and hiring for the church's administrative assistant and music director positions.
- 5. Implemented ability for people to make donations to St. Timothy's via Venmo.
- 6. The Pledge Secretary implemented changes to support the roll out of a new version of ParishSoft, the software we use for pledge tracking and other parish functions.

- 7. Reviewed and revised the strategy for one of our investment accounts to hopefully increase its returns. Proposed and got approval from the Vestry for a policy to allocate the 3-year average growth in our investment accounts (Schwab & TD Ameritrade) to help fund the campus and rectory long term maintenance & improvement accounts.
- 8. Prepared the 2021-2022 budget for Noah's Ark.
- 9. Prepared 2022 budget for St. Timothy's.

Finally, I would share comments about our financial results for 2021 and our financial plan for 2022:

2021 Results

- 1. We finished 2021 with positive net income of \$47,383 versus a planned shortfall of \$(52,230). This was mainly due to pledge income finishing \$33,557 better than budget, contributing income finishing \$14,697 better than budget and expenses underrunning the budget by \$53,074. Pledge income was better than planned due mainly to 35 families contributing \$26,524 more than they pledged and \$18,275 of 2020 pledges that were received in 2021.
- 2. St. Timothy's also did a lot to support outreach in our community and beyond in 2021 using special gifts, proceeds from our annual Fruits of the Harvest outreach event and amounts in the operating budget designated for outreach.

2022 Budget

- 1. The 2022 budget is based on 142 pledges, 16 fewer than the 158 pledges were made by the end of 2021.
- 2. Our 2022 budget shows a decrease in total income of \$(84,817) compared to the actual income for 2021. This change is mostly made up of a decrease of about \$(88,299) in Pledge Income and an increase of \$9,968 in Operating Support Income offset by a decrease of \$(853) in Plate Offering Income.
- 3. Our 2022 expense budget has increased about \$89,449 from the actual expenses for 2021, mostly due to:
 - a. \$1,051 increase in Diocesan assessment.
 - b. \$43,062 increase in Personnel Expenses mostly due to a 3.2% cola for staff.
 - c. Program increases
 - i. \$1,966 music
 - ii. \$2,750 children & youth ministry
 - iii. \$3,026 fellowship
 - iv. \$12,531 Facilities
 - v. \$14,754 Finance
 - vi. \$8,103 Contingency

- 4. The Finance Committee recommended and Vestry approved 2022 budget reflects a shortfall of \$126,882. The plan is to cover the shortfall with Unrestricted Net Asset funds.
- 5. There are two areas of concern in our church's financial picture. Given the shortfall in 2021 and the anticipated larger shortfall in the 2022 budget our church has an ongoing challenge with income to cover operating expenses and that gap is getting larger. Additionally, we continue to have a need to identify another \$100,000 in income annually to fund maintenance and improvement work on the campus and rectory properties. This work, prior to 2016, was funded by rent from the rectory, which was not being used as a rectory at the time, and cost sharing payments from the preschool and other long-term users of our facilities. This funding was allocated to the operating budget as part of balancing the operating budget in 2016 and replacement funding for our maintenance and improvement reserve has not been identified to date, leaving about \$63,000 remaining in the campus and rectory maintenance and improvement accounts. We will allocate the 2021 net income of \$47,383 and about \$15,900 from our investment account growth to partially replenish these two accounts in 2022.
- 6. Given the growing shortfall in the budget over the past couple of years, town hall meetings are being planned in February to share pledging and budget information. The goal is to help our parish understand some causes of our growing shortfall and gather input on actions that might be taken to help address our budget shortfall. Please watch for announcements about these meetings.

Finance Committee Report

Members: Neal Matsunaga (chair), Linda Clark (Senior Warden), Scott MacDougall (Junior Warden), Ken Anderson, John Jess and Charlie Wills.

The purpose of this committee is to help with the general management of the financial affairs of St. Timothy's, to act as an advisor on financial matters to the Vestry and to assist with any other duties relating to the business affairs of the parish that may be referred to it by the Vestry. The committee met monthly and when necessary, held special meetings to deal with issues that affected the finances of the church. It is also the committee's task to monitor funds invested by the church. To that end the committee reviews the church's investment portfolio quarterly. The committee makes recommendations to the Vestry, when needed, regarding the status of the church's portfolio. Currently the church has funds invested with Charles Schwab, SmartPortfolios (portfolio managed in TD Ameritrade) and the Episcopal Church Foundation/Endowment Management Solutions (State Street Global Advisors is the fund manager) and operating funds for both the church and preschool with Heritage Bank.

Some of the committee's work in 2021 included:

- 1. Completed filing for \$114,600 Payroll Protection Program loan forgiveness under the federal CARES Act
- 2. Reviewed Noah's Ark's 2021-2022 budget
- 3. Reviewed the church's 2022 budget
- 4. Reviewed the church's investment portfolio several times during the year
- 5. Started work on revising the church's Personnel Policy Manual
- 6. Researched options for improving returns from our investment funds and vestry approved using growth in these funds to help fund the campus and rectory maintenance & improvement reserve accounts.
- 7. Implemented Venmo as an online donation tool
- 8. Completed audits of the church's and preschool's 2019 and 2020 books and procedures. No written feedback from the auditor yet.
- 9. Revised church's gift policy for donations of shares of stock regarding how to price them.
- 10. Worked with BSA Scouts and the diocese regarding BSA Scout's bankruptcy filing and any involvement for St. Timothy's
- 11. Started research into alternative insurance carriers for the church's various insurance policies.

The music ministry at St. Timothy's Parish includes a choir of approximately 15 volunteer singers and 3 professional paid musicians. The choir provides all of the music at the 10:00 a.m. service including all of the hymns and the performance of an anthem during the offertory. The music ministry also includes a music director who serves as choir director and accompanist for the 10:00 a.m. choir and accompanist and vocalist for the 8:00 a.m. service. The music director takes an active role in liturgical planning and meets regularly with the Pastor and Co Pastor. Furthermore the music director is responsible for the selection of all hymns and anthems used during church services. The music ministry has several excellent pianos, and an extensive collection of choral octavos and other music.

Stephen Ministry

During this pandemic, you have demonstrated your generosity by reaching out to help others in their time of greatest need by giving funds, food, and support.

Fruits of the Harvest, (FOTH) fundraiser for all Outreach Ministries. The tag line for our 2021 event was "resilience, hope, gratitude and love"...those very characteristics which you showed. We had to pivot once again to a virtual fundraiser with the rise of Omicron. What we did in 2020 seemed to work beautifully. Our 24th Annual Fundraiser to benefit all Outreach Ministries was held at two Zoom coffee hours on September 19th and 26th. We sent out a printed invitation; an updated flyer about all our ministries and what they are doing during the pandemic; we created a website to allow the use of credit card donations; and Carolyn Bried created a new Outreach video to show how all our ministries were rallying to help their clients in this time of crisis. It's the most informative Outreach message to show the parish about God's Work that they support with the dollars they contribute The FOTH fundraiser netted over \$47,670. and with the addition of the \$15,000 church budget allotment and some rollover, we were able to give out \$61,700 in grants to all our ministries, including \$1,000 for Episcopal Relief and Development for immigrant relocation efforts. In addition, a grant of \$1,000 each was given to Episcopal Relief and Development for immigrant relocation efforts, School for Deacons, Church Divinity School of the Pacific, and Interfaith Council of CCC, which are line items in the church budget. Loaves and Fishes of Contra Costa County's mission is to provide community-based food programs and partner services that focus on basic needs. They are the largest provider of hot meals to the hungry in CC County, serving over 251,000 hot meals this fiscal year in five dining rooms. Loaves and Fishes has reached a major milestone in serving 5.3 million meals since 1983. They are serving twice the number of meals than they used to. With the new variant, L & F feels it is safer for staff volunteers, and guests to continue to serve to-go meals out the front door, including a bag of produce, and requires that masks be worn by all. They are looking forward to eventually having volunteers join them again. They miss us as much as we miss being there to work once a month. We have been on hiatus for almost two years. During the pandemic, Loaves and Fishes has accomplished a great deal. They have kept their staff safe, provided services with fewer volunteers, restarted their Culinary Arts training program, and opened a new Walnut Creek Dining room at Trinity Center, another one of the ministries that we support. Hot, to-go meals are available Mon. through Fri. from

12 to 1:15 p.m. and they encourage family, friends, and caregivers to drop by and pick up a meal for someone in need. L & F is working with a consultant and evaluating how to expand their services in 2022. One of the plans is to reach even more people in CC County through a mobile unit delivering food to partner agencies, and they are raising funds now for this new endeavor.

L & F has a new Executive Director, Sheila Aceves. Sheila brings a wealth of experience working with Bay Area non-profits with the Muscular Dystrophy Assn., the Boys and Girls Clubs of S.F and in several areas in the food and wine, and culinary education marketing. We welcome Sheila and hope to meet her soon.

Shelter, Inc is one of the largest nonprofits in Contra Costa, Solano and Sacramento counties preventing homelessness by providing housing and full wrap around services to help families be successful in permanent housing. Last year more than 23,000 women, children, and men (including many veterans) received help from Shelter Inc. programs in the counties they serve. In 2021 they received a \$5million grant from the Bezos Day 1 Families Fund - the largest philanthropic grant in their history.

Hope Solutions, formerly Contra Costa Interfaith Housing - provides low income, permanent housing for families and individuals. They have housed almost 2,000 people since their founding 25 years ago. Housing alone, without supportive services, is not enough to provide stability for this population. The Garden Park Apartments in Pleasant Hill, house and provide many supportive services for 28 families with children. In addition, Hope Solutions provides permanent supportive housing at scattered sites such as apartments throughout Contra Costa County for low-income families with disabilities for 265 individuals. 2021 has been a very challenging year. Many families faced job loss, reduced hours, the challenges of trying to work from home and support children with distance learning, an inability to visit family and friends, food insecurities, and mental health issues. These stressors are still being felt acutely by the residents and clients of Hope Solutions.

God's Hands Projects – The annual Backpack and School Supplies Drive for Hope Solutions was held on-line in July/August 2021 and again exceeded their goal of raising \$14,000 to provide 400 backpacks for children to

help bring them up to grade level. They partnered with an organization that provides everything in the backpacks for appropriate age levels. It's a very efficient way to do this. Thank you for your generous hearts.

Monumental Crisis Center – Food drives. MONUMENT CRISIS CENTER (MCC) has managed to weather the pandemic with heroic efforts of their staff. In April 2021, after 14 months without volunteers, they welcomed us back to the center to help with food distribution on Monday through Wednesday mornings. It is such a joy to see the staff and the other volunteers who revel in seeing each other and the clients and staff and doing something that directly helps those in need. It's one of the highlights of my week! Most of MCC's non-food programs are still NOT meeting in person but some have gone to Zoom, and others were being hosted in the front parking lot until the weather got too cold. When I was in the Center in early January, it looked like they were ready to see clients inside for the first time since March of 2020 but that event, like so much else, has been postponed. The St. Timothy's community and neighbors have been a consistent and generous support to the Center in 2021. We hosted 15 Food Drives for MCC during the year, from January through October collecting 24.5 carloads of food and paper bags and over \$8000 in donations.

Thank you to Carolyn Bried and Tania Hanson DeYoung for running the food drives. In November and December, we again participated in the MCC Christmas Food Box program filling over 163 boxes with food for client families. With the help of the Boy Scouts and recruited volunteers we loaded our boxes into trucks and cars and delivered them to MCC in time for the distribution after Thanksgiving. My deep thanks go to the sponsors, shoppers, Boy Scouts, sign-up helpers, and supporters. You are awesome!

Options Recovery Services has navigated COVID by reducing the numbers in transitional housing and doing classes on Zoom. The new Executive Director, Justin Phillips, delivered the sermons in September at St. Timothy's for Recovery Month. Options staff continues to grow, to serve the addicted, mentally ill, homeless, and formerly incarcerated. The prison trainings are now in 7 prisons, training Certified Drug and Alcohol Counselors. Options also delivers orientations in Reception Centers in prisons, to support new inmates in making the most of their time in prison, and has a section at Santa Rita to deliver drug and alcohol treatment. They are very appreciative of St. Timothy's support, as they will celebrate 25 years of service in September of 2022, with a project of refurbishing all of Options transitional housing.

God's Hands Project - Spread the Warmth Drive collection of socks, hats, mittens and scarves is on hiatus due to Covid-19.

Discovery Counseling Center in Danville has served the community with affordable, high quality mental health services for over 40 years. The offices in Danville and San Ramon Covid the therapists continue to provide critical mental wellness sessions. Major support usually comes from proceeds from the Thrift Station in Danville. The Thrift station has been able to open when in line with county pandemic guidelines.

Trinity Center opened its doors in 2013 in Walnut Creek to serve as a respite for the homeless community in our area. St. Timothy's has long been supporters of their programs both financially and with goods and services. During the chilly winter months Trinity houses qualified clients at night in the Walnut Creek Armory. St. Timothy's, through the generosity of a private donor, has been able to provide dinner at their new kitchen facility next to St. Paul's in St. Paul's Commons on four nights for the fifteen homeless night guests. On April 9th our church also provided the celebratory brunch (marking the end of the night program) for 80 people, including the night and daytime guests, and staff. Rodney Worth of the Peasant and the Pear, and Peasant's Courtyard, has been providing the St. Timothy's sponsored nutritious meals at a reduced cost to Trinity. *Liaison: Steve Mason*

Rise Against Hunger is an international hunger relief agency that has been working to end hunger for more than 15 years. Since we first starting hosting Rise Against Hunger in 2015, we have packaged over 100,000 meals which were distributed to schools, orphanages, and disaster sites world-wide. We have not held a meal packaging event since 2019 due to Covid. The Rise Against Hunger event is a great community building activity that parishioners of all ages can participate in. Outreach Committee plans to schedule an event when Covid conditions permit.

Winter Nights Shelter – Last year, Winter Nights Shelter was hosted at San Damiano Retreat Center in Danville with the five Danville/Alamo congregations that typically host the shelter providing meals, supplies and other support services. Following Covid protocols, and with the approval of the County

Health Department, Winter Nights is once again operating the rotating family shelter in Contra Costa County. With the help of St. Timothy's and Beth Chaim volunteers, we will open the Parish Hall to become a Winter Nights Shelter serving up to 30 guests (families with children). The shelter families will be coming to stay in the Parish Hall January 7 – 31. With the safety of everyone in mind, we will run the shelter with very few on-site volunteers. Masks are required except when eating and all volunteers, staff and guests must be vaccinated.

GAIA Global Health — The new name change of our partner organization shows the global impact it has on the health of those in need. They continue to provide community-based health services and education to under-served populations in rural communities while supporting health worker training to increase capacity and promote equitable deployment of frontline care providers. St Timothy's is so glad that their representative was able to join us during our live FOTH sessions in 2021.

Adopt a Family Bikes is a holiday community program started at St. Timothy's that takes in used bikes, has volunteers fix them, and then distributes them to those in need. 2020 & 2021 would have been our 18th & 19th years. Unfortunately, the program has been on hiatus due to COVID. Despite that, Joe Hui, a leading member, has repaired and distributed 21 bikes last year and 16 so far this year. Hopefully, the program will run in 2022 during November & December.

The Gretta Foundation provides nursing and midwifery full ride scholarships to disadvantaged individuals in Uganda. The scholars train in Ugandan schools. With St. Timothy's continued support over the years, we have 65 Gretta graduates, 44 scholars in school this school year, with 23 of those being in their first year. The schools in Uganda were closed due to the pandemic so when they finally opened, we pushed ourselves to fund all the scholars we could. *Liaison: Tania Hanson De-Young*

The Respite Inn is a 5019c)(3) nonprofit agency located in Concord. It is a unique service providing out-of-home respite and emergency services to adults with developmental disabilities. The Respite Inn was designed to provide families with needed time away from the constant care of their special adult. The Respite Inn was unable to provide on-site respite services during the first year of the pandemic. This past summer they began an alternate delivery of services by opening the inn for camp-style sessions where a limited number of clients come for a six-day 24 hours per day stay. Parents and families were thrilled. The Respite Inn also continues bringing clients together via Zoom for music, games, and story time.

Peace and Justice Ministry – For the second year now, St Timothy's Peace and Justice Commission could not have an annual **Fair-Trade Craft Fair** due to Covid-19. *Liaison: Mary Louise Gotthold*

Shawl Ministry - St. Timothy's knitting and crocheting group continues to make scarfs and caps distributed by the Seamen's Church Institute (SCI) for the mariners who come into the Oakland Dock Facility. This has been a difficult year for them as many ships cannot unload their person-al and are not able to come and go on a regular schedule. However, they still need warm scarfs & caps when they are at sea for extended periods of time, and we have been able to donate these items to them during the pandemic. We also make shawls and baby blankets for those in need or would just enjoy a handmade article. All are welcome to join us in this ministry. Please contact me for yarn and patterns

for the SCI program. We would be happy to have any extra yarn you would like to donate. Blessings and thanks to all who stitch and donate yarn for this effort.

The Comfort Cubs – Thanks to the generous support of St Timothy's Outreach, The Comfort Cub has been able to distribute a total of 126 Cubs to The Danville Discovery Counseling Center, Trinity Center, Options Recovery Services, Respite Inn, and Hope Solutions. The weighted therapeutic Cubs have been given to individuals that have suffered traumatic loss, emotional trauma and are also being used as a calming therapy tool for those suffering from pandemic-related anxiety. Recently, the Cubs were distributed to The Respite Inn. We received 24 thank you cards with photos of each guest holding their Cub. Executive Director Maureen Wright wrote "Our guests are ecstatic...the delight in their eyes when they walk into their room and see a Cub on their bed waiting for them is priceless. What a magical positive difference you and Comfort Cubs made." 40 Comfort Cubs have been provided to Hope Solutions for all three of their locations and will be distributed to the homeless children within their educational outreach program. Hope Solutions Educational Director, Deanne Pearn, called St Timothy's Outreach to personally thank St. Timothy's for enhancing the children's experience at Hope Solutions. The Comfort Cub feedback has been positively wonderful. The Comfort Cub is so incredibly grateful to St. Timothy's Outreach!

Habitat for Humanity/East Bay broke ground in 2021 on their new 42-townhome neighborhood in Walnut Creek! Esperanza Place, their first Zero Net Energy, climate-smart community, has been a long time in the making. Esperanza Place is located at: 1250 Las Juntas Way, near the Pleasant Hill Bart station. Thanks to the support of sponsors, donors, volunteers, and the entire Habitat community, they put shovels in the ground and are now busy getting ready to welcome volunteers on site early this year (2022). To report that 2021 was a year of transition for our parish is an understatement; however, 2021 was also a year of dedication, hard work, community building and cohesiveness despite all the challenges. A year that has reflected our commitment of being Christ's Hands in our outreach and our care for our members. We graduated three very dedicated Master Acolytes and sent them off to college and we trained five new acolytes. We celebrated the lives of seven individuals and baptized 5. We had one wedding.

We began to open our doors first on the patio, then in the newly remodeled Parish Hall and then in the sanctuary. We are grateful to our clergy for making sure our worship was safe requiring for a short time reservations to attend, mask mandates and social distancing. Requirements and terms that became common as we plowed through COVID 19.

Certainly, a highlight of our worship has been the live streaming. We began the year with a small group of parishioners, under 10 with masks and socially distanced, who each week met to cobble together a taped service to place on YouTube so we could all worship "together." Clergy would tape their sermons, Darita and the choir would zoom their beautiful music, lectors would submit their videos, altar guild would continue their behind-the-scenes efforts to make the sanctuary look beautiful and the tech team would amazingly put this all together. Technology became much more sophisticated with each Sunday and live streaming became a reality thanks to Don Perry, Kari Doolittle, Rand Mahoney, Ryan Mahoney and others.

Late in the Fall, the live streaming has become even better. Pastor Todd and the tech team (which has now grown with new members), has polished the production of the service with many cameras, lighting, and projection of the service on two large screens making access so much better for all in the sanctuary as well as at home. Although technology and the production of live streaming has been focal to our worship experience, the financial gifts of the parish and the individuals who served on the liturgy team made this happen.

We said "Farewell" to our beloved Music Director, Darita Seth and welcomed our new Music Director in November, Myles Ellis.

Columbarium Report

The Columbarium at St. Timothy's continues to be a place which reminds us of all the sacraments we celebrate as Episcopalians and allows for the remains of the deceased to stay on at the church that played an important part in their lives.

For 2021, despite the constraints imposed due to the coronavirus, the status of St. Timothy's Columbarium was:

- 5 interments were celebrated and 2 interments are pending.
- As of the end of the year 420 spaces are now licensed out of 736 spaces constructed (57%).
- As of the end of the year the Columbarium Maintenance Account balance is \$125,044.15.

The Columbarium Board is made up of four members appointed by the vestry for three-year terms plus the church Facility Manager, the Senior Warden and the Rector. The appointed board members, whose terms expire in 2022, are Jim Enes, Neal Matsunaga, Steve Oki and Sally Potts. The three ex officio members, the Rector, Senior Warden and Facility Manager, are Pastor Todd, Linda Clark and Bev Matsunaga.

Operation and maintenance of the Columbarium, preparation of niches for interments and assistance with interment services were managed and carried out by the Columbarium board and the Columbarium committee. Thanks to the board and committee for sharing their time and talent to help take care of our Columbarium and with interment services. There are always opportunities to help so if you are interested in joining this ministry, we would love to have you join us. If you have seen the Columbarium and thought you would like to be interred there, any of the board

members would be happy to talk with you and help you with a decision.

In closing I want to say thank you to the members of the Columbarium committee who have helped maintain the columbarium and assist with services in the columbarium, even during this difficult year.

Endowment Committee Report

Current committee members include Steve Bried, Darrell Klingman, Sue Klingman, Jim Stedman, Lisa Perry, Dick Firth, Neal Matsunaga, Todd Bryant, and Jim Pope (Chairman)

Fund Value: The current value of the Endowment fund is now over \$700,000, which is an increase of over \$100,000 from the end of last year. The increase in the fund was very good given the ups and downs of the market due to the pandemic.

Investment Risk Tolerance: Funds are conservatively invested in the Episcopal Church Foundation managed by State Street Global Advisors (SSGA). Endowment Fund Earnings Distribution: Per St. Timothy's Endowment Fund Guidelines, an annual distribution, if taken, is a restricted percentage of the earnings from the Fund (not the principal) and is limited to the amount equivalent to the three-year average return of the Fund.

No action, with respect to a transfer from the Endowment Fund to the St. Timothy's budget has been taken by the Endowment Committee in 2021. The Endowment Committee will consider a possible transfer in the future.

<u>Endowment Committee Programs</u>: We did not have an Endowment Program in 2021 due the COVID-19 pandemic. We'll look for an opportunity in 2022.

<u>St. Timothy's Legacy Society</u>: Remember when you give to Saint Timothy's Endowment Fund, you also become a member of the Diocese of California Legacy Society. If you have any questions or want information, please ask one of the Endowment Committee members (Listed above).

Junior Warden (Property Commission) Report

2021 was an odd year on St. Timothy's campus. There was a lot going on, even if many in our congregation had little opportunity to experience it in person.

The **Garden Project** was completed with special raised beds for herbs and flowers. Thank you to Jan Mahoney, Nora Hudson and Helen Robles for their work. It is commemorated with a nice plaque.

The **Parish Hall** saw the completion of its upgrade. Beautiful sound deadening materials were installed on the soffits and walls to complete the look and help with sound issues during coffee hour. Rob Wilson painted several closet doors. A new Parish Hall front door which has ADA capabilities was installed. Scott Pearsons replaced the horizontal beam on the cross in front of the Parish Hall.

Though things aren't getting a lot of use, the usual maintenance requirements still get attended to.

- Elevator The State was concerned about the firefighters emergency operation. It was resolved and testing can be done each month and logged in the elevator room. The State has provided a new permit which expires on December 30, 2021.
- Storm drain system continues to have problems due to tree roots. The line through the parking lot was
 "hydroed" twice to remove roots. That line needs to be kept clean so Grace House is not impacted
 again by heavy rains.

And then there are a few upcoming projects to be done this Spring

- The Tuff Shed in Noah's Ark Playground needs to be repaired because there is significant damage.
- The HVAC equipment at Ackerman needs to be replaced. Funds have been identified and work will happen in 2022.
- The back fence at Ackerman needs some work. A work party will be called in March to install new posts and add panels to replace the failing fence. If you feel handy and inclined to pitch in with this and other similar projects that come up not all that infrequently, send me an email and when the time comes, I will reach out.

Finally, I would like to thank the many people who have pitched in, in ways large and small, throughout the year. And in particular recognize and thank Bev Matsunaga who routinely takes care of everything. Without her, this place might fall apart. She is a treasure.
