Jeanette got up to speed fast with our new normal and worked seamlessly behind the scenes. Jacque is the behind the scenes go-to for keeping us on schedule. And finally, forgive the indulgence, but I'm super proud of my son and his reading as well as also grateful for my wife's indulgence in wearing a phone on her head to capture Palm Sunday and Good Friday.

Even after the shelter-in-place is lifted, it will almost certainly not be business as usual.

I want you to know that we are praying, working, and thinking about our new normal and how our campus worship will look with social distancing as well as safeguards for vulnerable parishioners. 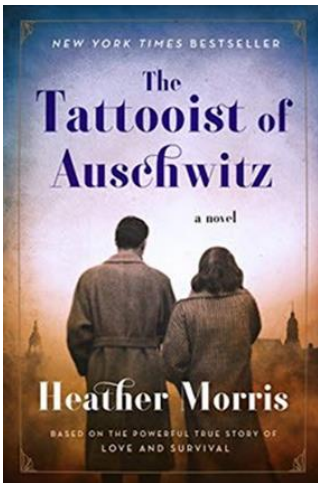

## ST. TIMOTHY'S BOOK GROUP



The St. Timothy's Book Group is alive and well and continuing to meet to support one another and discuss the

books we are reading. In April, we talked about Eleanor Oliphant Is Completely Fine. In May, we will discuss "The Tattooist Of Auschwitz" by Heather Morris. As of today, we don't know whether we will meet at church on May 17<sup>th</sup> or via Zoom. Contact Sally Shea Potts to be added to our group list and find out when and how we will meet.

Amazon describes The Tattooist as follows: In April 1942, Lale Sokolov, a Slovakian Jew, is forcibly transported to the concentration camps at Auschwitz-Birkenau. When his captors discover that he speaks several languages, he is put to work as a Tätowierer (the German word for tattooist), tasked with permanently marking his fellow prisoners.

Imprisoned for over two and a half years, Lale witnesses horrific atrocities and barbarism—but also incredible acts of bravery and compassion. Risking his own life, he uses his privileged position to exchange jewels and money from murdered Jews for food to keep his fellow prisoners alive.

One day in July 1942, Lale, prisoner 32407, comforts a trembling young woman waiting in line to have the number 34902 tattooed onto her arm. Her name is Gita, and in that first encounter, Lale vows to somehow survive the camp and marry her.

A vivid, harrowing, and ultimately hopeful re-creation of Lale Sokolov's experiences as the man who tattooed the arms of thousands of prisoners with what would become one of the most potent symbols of the Holocaust, The Tattooist of Auschwitz is also a testament to the endurance of love and humanity under the darkest possible conditions.

## EPISCOPAL IMPACT RELIEF

You may have read in the April 7<sup>th</sup> edition of Diocal that the Episcopal Impact Fund, the outreach arm of the Diocese of California, set up an emergency fund to help local organizations which are on the front lines of addressing the most pressing needs during this terrible time.

Liaison Sally Potts brought this to Monument Crisis Center's attention and Sandra Scherer immediately applied. We were thrilled to get notification on April 13<sup>th</sup> that Monument Crisis Center was getting a check that day for \$10,000. Monument Crisis Center has been distributing food to anyone that needs it. During the week of March 23, on three days, in nine hours, Monument Crisis Center distributed over 35,000 pounds of emergency food to over 900 families feeding over 3,000 individuals! They continue to distribute food weekly, two days a week for three hours each day with a staff of only 7 people.

Please keep the staff at St. Timothy's in your prayers. The food barrels will remain outside of Grace House for donations until St. Timothy's is open again.

## STEWARDSHIP SNIPPET

Acts 2:46-47a - Day by day, as they spent much time together in the temple, they broke bread at home and ate their food with glad and generous hearts, praising God and having the goodwill of all the people.

## TAX LAWS FOR CHARITABLE CONTRIBUTIONS

The recently passed Coronavirus Aid, Relief and Economic Security (CARES) Act, included several provisions that encourage people to give this year and have less taxes owed when they file in 2021. These items could affect public charities like St. Timothy's. Two in particular are:

1. For taxpayers who do not normally itemize on their tax returns (i.e. take the standard deduction) there is a new \$300 per taxpayer (\$600 for a married couple) deduction for cash gifts to public charities for 2020. There are some rules such as the money has to go directly to a charity (donations to donor advised funds and certain organizations that support charities are not deductible) and must be in cash (no stocks, in kind service or property).
2. For taxpayers who itemize deductions on their 2020 tax return, the cap on how much in cash gifts to public charities a donor can deduct in a single year is lifted. Prior to 2017 the cap was no more than 50% of adjusted gross income (AGI) then with the 2017 Tax Cuts and Jobs Act (TCJA) the cap was raised to 60% of AGI and now with the 2020 CARES Act the cap is eliminated entirely for 2020, making gifts of as much as 100% of AGI deductible in 2020.

Finally, a reminder, that the tax law for years now has contained a provision called Qualified Charitable Distributions (QCD) that can be useful to some taxpayers. A QCD is a direct transfer of funds from your IRA custodian payable to a qualified charity (e.g. St. Timothy's) that can be excluded from taxable income. This can be useful for taxpayers who do not itemize (i.e. take the standard deduction) as it can be used to reduce their taxable income. This provision requires taxpayers to be at least 70 1/2 and is limited to a maximum of \$100,000 per year.

By remaining open and serving under these challenges, we are incurring unexpected costs related to the "to-go" containers, gloves, masks, gowns, sanitizers, cleaning rags and supplies. Additionally, with the cancellation of two of our largest fundraising events, we are projecting a deficit of \$95,000.

Over the last 4 weeks, we have seen our meal counts increase by 10-28% depending on the dining room location as more people are in need of food in our county. Please consider making a donation today to help us continue to feed those in need.

- **COVID-19 UPDATE:** We are deeply appreciative for your partnering with Hope Solutions. It's through our partnership with one another that we are able to address the catastrophic effects of homelessness. But, unfortunately, it's the homeless and formerly homeless clients we serve that are among those most at risk of suffering dire health consequences if they contract the COVID-19 virus. Our staff are on the front lines providing care, education, supplies and support to all our residents during this time.
- Your donation to the **Emergency Fund** will allow Hope Solutions to maximize our efforts to keep the individuals and families we serve on the path of housing stability within a healthy environment and provide the services one would need to thrive.

Hope Solutions has made great strides in mitigating homelessness by expanding our housing navigation function by more than five-fold. Now in its third year, this program brokers housing by partnering with landlords to lease units for residents who are homeless and have special needs or disabilities. In the past fiscal year our team has managed to help more than 200 people, 99% of whom remain stably housed.

In 12 months, across all of our programs, 262 people were housed in 152 units. Not only do residents deserve a new place to call home, our program provides cost-effective housing resources that prevent use of high-cost emergency room visits, hospitalizations and incarcerations.

## VESTRY MEETING HIGHLIGHTS

St Timothy's Episcopal Church Vestry Meeting Highlights – March 2020

The vestry met using Zoom on Sunday, April 5th at 12:00 pm and Wednesday, April 15, at 4:30 pm.

### MOTIONS:

- In late March, the vestry voted via Doodle Poll and email to approve renovations to the Parish Hall. The glass on the patio and Clydesdale Avenue sides of the building will be replaced and the hall will be repainted. The renovations are currently on hold due to the COVID-19 pandemic
- On April 5th, the vestry approved the loan application on behalf of the St. Timothy's parish and the Noah's Ark preschool for a CARES Act Paycheck Protection Program.
- The vestry voted to approve donating \$10,000 from the Outreach Emergency Fund to 6 local charities (who have all been supported in the past by St. Timothy's) to help them in the current COVID-19 crisis. The donations were proposed by the Outreach Committee and reviewed by the Finance Committee.
- The vestry approved suspending the cost sharing fees for AA, ACA, and TOPS during the current COVID-19 crisis. Note: None of the listed organizations are currently using the facilities at St. Timothy's.
- The March meeting minutes, the April emergency Vestry meeting minutes, summary of the March email vote on Parish Hall renovations, treasurer reports and Outreach and Property commission reports were approved as submitted.

### ACTION ITEMS:

- Vestry Calling: The vestry will again contact parish members based on the February directory and their experience calling "their list" during March.
- Noah's Ark Board: Rayne Devlin and Kari Doolittle are looking for an additional member for the Noah's Ark board from the parish.

At an emergency vestry meeting on April 5th using Zoom, Neal Matsunaga briefed the vestry on the proposal to apply for a CARES Paycheck Protection Loan on behalf of the church and the preschool. The vestry approved the application.

Neal Matsunaga updated the vestry on the impact of the pandemic on church finances based on data through the end of March.

Neal Matsunaga informed the vestry that the parish has received a check for \$1000 from the Diocese of California to help local organizations during the pandemic.

Pastor Todd briefed the vestry on the plans for the Bishop's virtual visit on April 19th.

The planned Fruits of the Harvest Outreach fundraiser on Saturday, May 16th has been cancelled. Plans for fundraising for Outreach are in process

Parish members are welcome to attend Vestry meetings. The next meeting is on Wednesday, May 20, 2020.

The minutes of the vestry meeting will be filed in the Parish Office after they are approved by the Vestry.

# TREASURER'S REPORT

April 15, 2020

## Financial Highlights

- Financial results through March appear to be positive. Income underrun is mainly due to pledges that have not been paid yet to date and expenses reflect slowdown in expenses due to shelter in place rules and winter weather.
- Pledge income in our approved budget for 2020 is based on 159 pledges and includes an assumption that at least 6 additional pledges for at least \$13,400 will be received. Through March 2 additional pledges for \$12,620 have been received. Our budget has a revenue shortfall of about \$58,400 (\$13,400 more pledge dollars assumed and projected deficit of \$45,034). The hope is that new pledges will be received during the year, as in 2019, but there is also an opportunity and challenge for parishioners to make or increase their pledges.
- 24 pledges for \$106,020 have not made any payments yet in 2020. Last month this number was 42 pledges so thank you.
- 23 pledges are paid in full for \$113,710. Last month it was 19 for \$94,969.
- 2020 budget vs actual results, through March, adjusted for amortizing "pledges paid in full" in the current year:

## Income

Pledge income difference due to about \$26,500 for pledges that have not made any payments yet.

Other Income difference due to:

Plate Offerings \$(1,800) under budget.

Expenses – Operating expense difference is the sum of several over and under budget items, with main ones being:

Personnel expenses \$3,640 under budget

Altar Guild expenses \$(400) over budget due to December flower bill paid in 2020.

Music expenses \$360 under budget.

Children & Youth Ministry expenses \$890 under budget.

Fellowship expenses \$510 under budget.

Administrative expenses \$2,010 under budget due mainly to quarterly copier leases paid in March and less office supplies and paper expense.

Facilities expenses \$4,930 under budget due to campus and rectory maintenance being under budget and services being over budget.

Finance expenses \$(4,890) over budget due to timing of quarterly insurance bill payment.

Contingency expenses \$910 under budget.
